**AN ORDINANCE
TO AMEND
CHAPTER 257 OF THE CODE
OF THE TOWNSHIP OF MAPLEWOOD
Entitled
"Vehicles and Traffic"**

"Interpretive Statement"

This ordinance will implement time limit parking on Tuscan Road between Valley Street and Prospect Street.

WHEREAS, the Township Engineering Department in consultation with Township Planning and Engineering Committee has recommended that time limit parking be placed on Tuscan Road between Valley Street and Prospect Street; and

WHEREAS, the implementation of time limit parking will best serve the residents of the Township of Maplewood.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey, that Chapter 257 of the Code of the Township of Maplewood entitled "Vehicles and Traffic" be amended as follows:

FIRST: **Section 257-53** **Schedule XVII: Time Limit Parking**
Shall be amended by adding the following:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit; Hours/Days</u>	<u>Locations</u>
Tuscan Road	South	2 hours: 7:00 a.m. to 10:00 a.m. Mon. thru Friday	From a point 180 feet from Valley Street to a point 230 feet from Prospect Street.

All other sections shall remain unchanged.

SECOND: **Severability**

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph,

subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

THIRD: Repeal of Prior Ordinances

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

FOURTH: Effective Date

This Ordinance shall take effect after final passage and publication and as provided by law.

"Interpretive Statement"

This ordinance will designate 44th Street as a one-way street with traffic flowing from East to West.

BE IT ORDAINED, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey, that Chapter 257 of the Code of the Township of Maplewood entitled "Vehicles and Traffic" be amended as follows:

FIRST: Section 257-39 entitled "One-Way Streets" shall be amended to add 44th Street as a one-way street as follows:

<u>Name of Street</u>	<u>Direction of Traffic</u>	<u>Limits</u>
44th Street	East	From Chancellor Avenue to Jacoby Street.

All other sections shall remain unchanged.

SECOND: **Severability**

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

THIRD: **Repeal of Prior Ordinances**

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

FOURTH: **Effective Date**

This Ordinance shall take effect after final passage and upon approval of the County of Essex and publication and as provided by law.
