**AN ORDINANCE TO AMEND CHAPTER 257  
OF THE CODE OF THE TOWNSHIP OF MAPLEWOOD  
ENTITLED  
"VEHICLES AND TRAFFIC"  
(Durand Road)**

*"Interpretive Statement"*

*This ordinance will change the parking on Durand Road between Woodland Road and Maplewood Avenue from commuter parking to two (2 hr) hour parking.*

**BE IT ORDAINED**, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey, that Chapter 257 of the Code of Township of Maplewood entitled "Vehicles and Traffic" be and is hereby amended as follows:

**FIRST:**

**Section 257-61, Schedule XXV: Permit Parking** This Section is amended as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Hours/Days:</u>	<u>Location</u>
Durand Road two	South	6:00 a.m. to 9:00 a.m. Mon. - Fri. except holidays.	From a point one hundred seventy- (172') feet west of Maplewood Avenue to Woodland Road.

**SECOND:**

**Section 257-53, Schedule XVII: Time Limit Parking** This Section is amended by adding the following:

<u>Name of Street</u>	<u>Side</u>	<u>Time Limit; Hours/Days</u>	<u>Location</u>
Durand Road	South	2 hrs. 8:00 a.m. to 7:00 p.m./All	From a point forty (40') feet west of Maplewood Avenue to a point one hundred seventy-two feet west

thereof.

**THIRD: Severability**

If any section, paragraph, subparagraph, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the specific section, paragraph, subparagraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**FOURTH: Repeal of Prior Ordinances**

Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of any such inconsistencies.

**FIFTH: Effective Date**

This Ordinance shall take effect after final passage and publication according to law.

**PUBLIC NOTICE** is hereby given that the foregoing proposed Ordinance was introduced and read by title for the first time at a meeting of the Township Committee of the Township of Maplewood, held on August 1, 2006, the Committee met again on September 5, 2006 at 7:30 p.m. at which time amendments were introduced, and that the Committee met again on September 19, 2006, at 7:30 p.m. at the Municipal Building, 574 Valley Street, Maplewood, New Jersey, at which time and place the Committee proceeded to consider the said Ordinance on second reading and final passage.
