### RESOLUTION APPROVING AGREEMENT WITH PBA LOCAL 44A

**WHEREAS**, the Superior Officers of the Maplewood Police Department in the Township of Maplewood ("Township") are members of Police Benevolent Association Local 44A ("PBA Local 44A"); and

**WHEREAS**, PBA Local 44A has worked within the Township without a contract; and

**WHEREAS**, PBA Local 44A and the Township are presently engaged in Interest Arbitration; and

**WHEREAS**, PBA Local 44A and the Township have agreed to settle the pending Interest Arbitration upon the terms agreed to in a Memorandum of Agreement dated July 8, 2009, (copy attached); and

**WHEREAS**, PBA Local 44A at a Special Meeting held on July 10, 2009, voted to approve the Memorandum of Agreement dated July 8, 2009.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Maplewood, County of Essex, State of New Jersey that:

- 1) The Memorandum of Agreement dated July 8, 2009, with PBA Local 44A, be and is hereby approved; and
- 2) The Township expresses its gratitude to PBA Local 44A for its hard work and cooperation in resolving this matter.

MEMORANDUM OF AGREEMENT  
TOWNSHIP OF MAPLEWOOD AND SOA LOCAL 44A  
July 8, 2009

1. Wages

- 2007: 7.0%
- 2008 3.0%
- 2009 0.0%
- 2010 3.0%
- 2011 3.5%

2. Differential: A 12.0% differential will be established between ranks effective January 1, 2010.

3. Health Insurance: Each member will contribute \$500 per year toward the cost of health insurance effective January 1, 2010

4. Stipend: The supervisor of the Youth Aid Bureau and the Detective Bureau will receive an annual stipend in the amount of \$1934.

5. Educational Stipend: The Township will pay the following stipends for educational degrees from accredited colleges and universities:

- Associate's Degree: \$250
- Bachelor's Degree: \$500
- Master's Degree: \$750

6. Contractual Language: The Township will agree to establish a new collective bargaining agreement containing the terms of the PBA contract that are not inconsistent with the terms of this Memorandum of Agreement.

7. This Memorandum of Agreement is subject to adoption by the Township Committee and the membership of the SOA.

8. The parties agree that Timothy Hundley will retain jurisdiction over matters involving the interpretation of this Memorandum of Agreement and the interest arbitration if necessary.
